**NEW BUSINESS**

**Bill No. 2025-35: Approving 3% Local Use Tax:...UNDER EMERGENCY MEASURE...1st, 2nd, and 3rd Readings**

AN ORDINANCE of the City of Neosho, Missouri, submitting to the electors of the City of Neosho, at an election on Tuesday August 5, 2025, the question of whether the City shall impose a local use tax at the same rate as the total local sales tax, currently three percent (3%) on all retail sales subject to taxation pursuant to the provisions of Sections 144.600 through 144.761 RSMo; providing for the use tax to be reduced or raised in the same amount as any City sales tax is reduced or raised; and imposing a local use tax of 3% on all retail sales subject to taxation pursuant to Section 144.757 RSMo, upon the approval of a majority of the qualified electors voting; and prescribing a form of ballot thereof; taken up under emergency measure.

City Attorney Snyder read Bill No. 2025-35 in title only.

Councilman Workman made a motion to approve and discuss Bill No. 2025-35; Councilwoman Humphrey seconded.

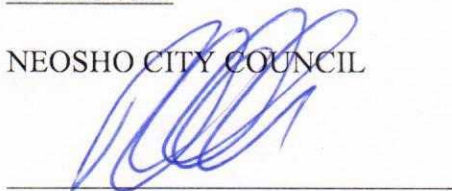

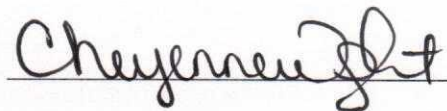
