Bill No. 2022-79: Contract with Stafford Fencing for the Scenic Park Dog Park.

AN ORDINANCE authorizing the City of Neosho, Missouri, to enter into an Agreement for Construction Services with Jeremy and Candace Stafford, d/b/a Stafford Fencing, for the purpose of constructing a dog park in Scenic Park located at 1500 N. Main Ave., Neosho, MO 64850, for the not to exceed price of Seventeen Thousand Two Hundred Sixty and 00/100 Dollars (\$17,260.00); and authorizing the Mayor to execute the same by and on behalf of the City of Neosho.

Councilwoman Thomas made a motion to Approve and Discuss Bill No. 2022-79: Contract with Stafford Fencing for the Scenic Park Dog Park; Councilman Cobb seconded.

Bill No. 2022-80: Contract with Construction Services Group, LLC for Construction of Morse Park Restrooms

AN ORDINANCE authorizing the City of Neosho, Missouri, to enter into an Agreement for Construction Services with Marion Company, LLC, a Missouri Limited Liability Company, d/b/a Construction Services Group, for the purpose of constructing restrooms at Morse Park for the not to exceed price of One Hundred Sixteen Thousand Seven Hundred Ninety-Five and 00/100 Dollars (\$116,795.00); and authorizing the Mayor to execute the same by and on behalf of the City of Neosho.

Attorney Paul read Bill No. 2022-80 in title only.

Councilwoman Robinson made a motion to Approve and Discuss Bill No. 2022-80: Contract with CSG, LLC for Morse Park Restroom Construction; Mayor Pro Tempore Davidson seconded.

Attorney Paul addressed the Council. There was an error in the bid that it was sent out without prevailing wage in the bid documents. This bill will need to be amended during the next meeting due to an increase in cost.

City Manager Kennedy addressed the Council stating that this is for the construction of the Morse Park restrooms and is the contract with CSG, LLC for this construction.

Bill No. 2022-81: Contract with Double Down Asphalt for the Golf Course Cart Path

AN ORDINANCE authorizing the City of Neosho, Missouri, to enter into an Agreement for Construction Services with Double Down Asphalt Services, LLC, a Missouri Limited Liability Company, for the purpose of constructing improvements at the Neosho Municipal Golf Course located at 1850 Clubhouse Road, Neosho, MO 64850, to include golf cart path overlay and repair, for the not to exceed price of One Hundred Twenty Thousand Six Hundred Thirteen and 00/100 Dollars (\$120,613.00); and authorizing the Mayor to execute the same by and on behalf of the City of Neosho.

Attorney Paul read Bill No. 2022-81 in title only.

Councilwoman Thomas made a motion to Approve and Discuss Bill No. 2022-81: Contract with Double Down Asphalt for the Cart Paths; Councilwoman Robinson seconded.

Public Works Director Siler addressed the City Council stating that the purpose of this agenda item is to seek approval of the contract with Double Down Asphalt for the cart paths at the Neosho Golf Course in the amount of \$120,613.00.

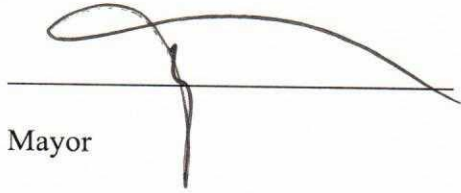

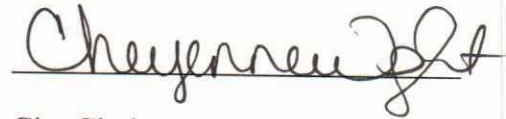
