He was requesting payment from the city for the connections since he put in the line.

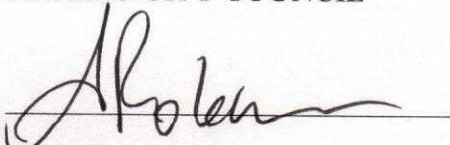

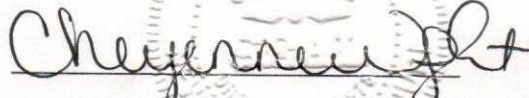
